IT'S LOBBY WEEK!

As I write this column, AAUW CA is in the middle of Lobby Week at the State Capitol. How does this work? AAUW CA has selected 30 bills to support for this current legislative session. From the 30 bills, three bills were selected as top priority to be presented during our lobbying efforts this week.

Who was the lobbying crew? **Carol McMillan** and I attended mandatory training on Monday night on Zoom and learned that 120 members statewide had been recruited to participate from 50 branches. Five girls who just finished the Gov Trek training also joined in. AAUW was much more successful this year in scheduling meetings with legislators and staff. Some of the meetings are in person and some are on Zoom. Generally, AAUW teams of 4 or 5 make the case for the bills, while also describing AAUW and branch activities.

Our Branch, along with the Auburn Branch, scored an in-person meeting with Senator Brian Dahle that we participated in today. Although he did not make a commitment to our top three bills, we all thought it went well.

Top Three Bills for Lobbying Efforts

AB 1394 – California Social Media Platform Liability for Child Sexual Abuse and Trafficking introduced by Buffy Wicks. Since 2000, traffickers have recruited 55% of sex trafficking victims online, usually through social media platforms. AB 1394 would allow victims of child sex exploitation to sue large social media platforms to seek damages of \$1 to \$5 million for each act of exploitation if the platform knowingly, recklessly or negligently facilitated, aided or abetted child exploitation.

SB 287 – California Social Media Platform Liability For Child Addiction and Harms introduced by Nancy Skinner. Our youth are currently experiencing an unprecedented mental health crisis, and researchers attribute a significant part of the cause to their social media use. During the time that Instagram use rose from 1 million to 1 billion users, suicide among girls age 10-14 doubled. Instagram knowingly worsened body image issues for 1 in 3

teenage girls. SB 287 would prohibit social media platforms from knowingly or negligently using a design, algorithm, or feature that causes child users to purchase drugs, inflict harm on themselves, develop an eating disorder, take their own lives or experience addiction to social media. Platforms could be liable for \$250,000 for each violation unless they

institute quarterly audits and correct problems within 30 days of discovery.

AB 539 – The California Elimination of Discrimination Against Women Act introduced by Assembly members Rebecca Bauer-Kahan and Lisa Calderon. AB 549 would require all state agencies to conduct an evaluation of all their departments to ensure the state does not discriminate against women, including examining the implementation of policies and programs, allocation of funding, and delivery of services. The findings would be reported every two years (beginning in 2025) to the California Commission on the Status of Women with recommendations for necessary changes.

Senator Brian Dahle listened to us and gave us enough time to present our ideas, despite the fact that his receptionist kept knocking on the door saying he was going to be late to his next meeting. He seemed most interested in the bills that work to protect young girls, noting that he has a 13-year-old daughter.

We are scheduled to meet with a staff member for Assemblywoman Megan Dahle on Friday. We will see how that goes, but it already seems like Lobby Week for AAUW is a success, and it feels good to be heard!

organization linked to the Branch by the terms of the trust.

Three Branch members serve as trustees: Ann Shulse, Joanne Weatherly, and Cheryl Morris. They work closely with a pro bono

financial adviser. Trustees serve without term limits and would like to have possible successors in place. If the opportunity to serve in this role in the future is of interest to you, please contact any of them for more information.

Tapas and Trivia is the Branch fundraiser for local scholarships. Thus, when you participate in this event, besides having fun you are contributing directly to our scholarship program.

The Local Scholarship Committee is made up of

the trustees and volunteers from the Branch. The committee decides the number and amount of scholarships awarded each year as well as selecting the recipients. Please refer to Rhea Williamson's article in last month's Lodestone for more details about the current variety and amounts of the scholarships.



On **Thursday April 27th** the Garden Group is going to the Wakamatsu Tea and Silk Farm Colony, the first permanent Japanese settlement in North America and the only settlement by

samurai outside of Japan. The group was made up of 22 people from samurai families that purchased land in the Gold Hill region near Placerville in 1869. They brought with them mulberry trees, silkworm cocoons, tea plant and bamboo shoots, cooking utensils, and swords. Though the group was able to successfully show their produce during the 1869 California State Agricultural Fair in Sacramento and the 1870 Horticultural Fair in San Francisco, the farm as a Japanese colony only existed between 1869 and 1871. Okei Ito, the first known Japanese woman to be buried on American soil, has her grave on the land. A private tour will provide insights to the history, motivations and outcomes of this intriguing farm colony, followed by a self-provided picnic lunch on the beautiful grounds. \$10 donation. Solito by Javier Zamora



Solito is the story of Javier Zamora's 3000-mile journey from a tiny village in El Salvador to Arizona in 1990. He was nine years old. And he was "solito" or alone as the title in Spanish translates. Zamora's father had immigrated to the United States five years earlier. His mother left and


the same "coyote" or guide was slated to bring Zamora and a small group of other immigrants north.

What sets this story apart from the sea of similar tales of woe is the childish perspective of a nineyear-old boy. Tossed into a group of strangers, Zamora faces incredible hardships crossing wild seas, unforgiving deserts, and hostile border crossings. Yet he starts out embarrassed to use a public bathroom on his own. The world is a perilous place, yet the story focuses on the humanity that Zamora encounters with his traveling companions, who save his life time after time. A family emerges.

The Mostly Fiction Book Group read American Dirt last year, a book that was widely criticized

for trivializing the trauma of the immigrant experience. This book is the perfect counterpoint because it highlights the kindness and the humor of Mexican culture. Solito shows humanity at its finest even in the darkest of times.

Zamora is a poet and his words paint a beautiful and harrowing picture of a life-changing journey.



What was supposed to take two weeks, stretched to seven weeks. Zamora's parents had no contact during that time. And when the small group finally made it to the border, it took several trips, that nearly killed them, to finally make it across.

Anyone who wants to understand the immigrant experience should read this beautiful book.


cargo ship with captured Africans landing in 1619. This bestseller explores the legacy of slavery and its connection to present-day situations in our country.


