PUBLIC POLICY NEWS

GOOD NEWS

Yes, let's start with good news! We really need it, and the November election brought some important wins when it comes to women's rights.

1. Ohio passed the "Right to Reproductive Freedom with Protections for Health and Safety Initiative." This was a citizen-initiated constitutional amendment that was approved on November 7 by a majority vote of 56.6%. It codified reproductive rights in the Ohio Constitution, including contraception, fertility treatment, whether to continue one's pregnancy, and miscarriage care; restoring Roe v. Wade-era access in Ohio by

protecting the right to abortion up to the point of fetal viability.

2. In Virginia, Democrats held on to their state Senate majority and won back a majority in the House of Delegates. Yes, AAUW is non-partisan and does not support candidates. However, according to a recent AAUW National fundraising letter, "we are political because our mission includes holding leaders accountable for giving women equal opportunities to learn, earn, and lead." In the case of Virginia, Governor Glenn Youngkin and the GOP legislative priorities include banning abortion and stripping away LGBTQ+ rights. We CAN celebrate an important election that helps protect women's and minority rights!

3. In California, many of AAUW-CA priority bills were passed by the California Legislature and signed by Governor Newsom. AAUW-CA supports and tracks numerous pieces of legislation and ranks them Level A (the highest priority), Level B, Level C, and Watch. Of the 2023 bills, 18 were transitioned to 2-year bills, 19 were signed into law, and 3 were vetoed. One Level A bill (AB 1394), 2 level B bills, 15 level C bills, and 1 Watch bill were signed into law. AB 1394, authored by Assemblymember Buffy Wicks, and co-sponsored by AAUW-CA, will help child sex abuse survivors remove their images from social media platforms, holding Big Tech accountable for design features that knowingly, recklessly or negligently facilitate, aid, or abet child exploitation.

PENDING GOOD NEWS?

The U.S. Department of Education has missed its own deadline to release new final Title IX rules, weakened by the Trump Administration. The new Title IX rules are expected to restore protections against sexbased discrimination, clarify protections for LGBTQ+ students, strengthen

support for pregnant and parenting students, and provide clarity on transgender students' participation in athletics.

BAD NEWS

Election conspiracy theorist
Congressman Mike Johnson from
Louisiana was elected Speaker of the
House. Mike Johnson supports a
nationwide abortion ban and was
quoted in the wake of the Dobbs
decision to say, "we will get the
number of abortions to zero." He is a
very far right conservative. This is very
scary in terms of women's rights, to say

nothing of the threat to our democracy itself.

WHAT CAN YOU DO?

- 1. Write to the U.S. Department of Education asking them to take immediate action to finalize the new Title IX rules to restore civil rights protections of students regardless of gender, color, or sexual orientation.
- 2. Write to Congressman Kiley asking him to support/co-sponsor the Family and Medical Leave Insurance (FAMILY) Act (HR 3481). The FAMILY Act would provide workers with up to 12 weeks of paid leave when they take time off for a serious health condition impacting themselves or their family.
- 3. Get ready for the 2024 election year. I don't think it has ever been more important. The California primary is on March 5th, just around the corner. Look for candidates who will support AAUW's mission, including equity and women's right to choose. At the Congressional level, look for a candidate who will select a Speaker who will not put women's rights at risk. Support those candidates and be sure to vote!




