STEAM Fair

Thirty middle-school girls spent Saturday, May 17th at the Bright Ideas STEAM Fair, co-sponsored by AAUW Nevada County and Bright Futures for Youth (BFFY). The free event was the result of a national AAUW community grant to work together to infuse science, technology, engineering, art, and math (STEAM) into BFFY's Friendship Club. Open to the public, all 2025 Tech Trek nominees plus eligible Tech Trek alums were invited, and older alums plus AAUW members and local teachers volunteered to help out.

The day included engaging workshops in coding, anatomy, and math (Code It, Shape It, Print It; Bones in Motion: What a Chicken Wing Can Teach a Doctor; Pop-Up Shop Show) and opportunities to meet women in STEAM-related careers, including AAUW members Laurie Segal (engineer) and Valarie Bush (pilot). Surveys showed very positive reviews of the day: 100% of participants reported they learned something new with the majority (67%) marking "a lot" or "very much."
