# Public Policy: Prop 50 & Other Legislation

# Can We Stay Neutral?

As we kick off the new year, many new challenges present themselves to setting our priorities and furthering our mission.

This November, Californians will be asked to vote on Prop. 50, which would approve drawing new district boundaries for future elections (notably those in 2026 & 2028), until maps are redrawn in 2030.

Non-partisan organizations, like the League of Women Voters and Common Cause, have normally argued against any type of gerrymandering; these organizations have supported leaving district line redraws up to California's independent commission, established for that purpose. However, these are not normal times, given the current threats

to our democracy. Thus, both organizations have declined to take a position on Prop. 50.

AAUW is also avoiding a clear position on Prop. 50, but wishes to inform voters about what is at stake in this election. That information is put forth in the article following this and is written by the AAUW-CA Public

Policy Committee. We encourage you all to vote and hope you find the article helpful in your decision-making about this issue.

#### OTHER CALIFORNIA NEWS

Two of AAUW-CA's top bills reached the Governor's desk. They were part of our Lobby Day focus, and **Lisa Schliff** and I were able to recommend them to California legislators. Two others reached the Governor's desk that are worthy of note, including one that would have positive impacts for women and children in our general area, and was co-authored by our own Senator Megan Dahle. Here are all the noteworthy bills:

1. AB 771 was sponsored by AAUW-CA and authored by Senator Henry Stern. It clarifies that a social media platform may be liable for civil penalty under existing law if and when its algorithms or AI aid and abet individual users who are engaging in already unlawful intimidation of others in online spaces.

2. AB 418 is strongly supported by AAUW-CA and authored by Senator Caroline Menjivar. It would prohibit a health plan or a health insurance provider from denying coverage or denying benefits to a person based upon their race, color, national origin, age, disability, or sex - including sex



characteristics such as intersex traits, pregnancy, and gender identity.

3. AB 260 would allow health care providers to mail abortion pills to patients in other states without listing the patient's or prescriber's names on the package. The bill aims to shield providers who mail the pills to states

> with abortion bans from legal action and to protect patients from potential identification and repercussions.

> 4. SB 669, co-authored by Senators Megan Dahle (R) and Mike McGuire (D), would create a pilot program for up to five critical-access rural hospitals, developed by Plumas District Hospital to fulfill its

commitment to provide maternity care, by allowing hospitals to staff labor-and-delivery services on a "standby" basis, with medical teams available within 30 minutes, instead of 24/7. Round-the-clock staffing has proved impossible to sustain in many rural communities, leaving pregnant women no local option for delivery at all. Traveling long distances is itself dangerous to women and their babies.

**Breaking news:** Governor Newsom on September 26 signed AB 260. In addition, aside from those mentioned above, he signed other bills protecting a woman's right to privacy and access to contraceptive care: AB1525, AB 45, and AB 50. He still has until October 12 to sign all the rest mentioned above. Let's keep our fingers crossed!

If you attended the September meeting, you received your Membership Directory. If you were not at the meeting, you should receive it in the mail.


**Emily Frost** produced the Membership Directory, and she also came up with a method by which we might include member photos in our online roster.
