Understanding the Role of the Judiciary in Our Democracy

The primary roles of the judiciary in the American democratic system are to interpret laws, protect individual rights, ensure justice by resolving disputes fairly, check government power through judicial review, and uphold the rule of law. These functions help maintain the balance of power, safeguard constitutional rights, and ensure that laws are applied consistently and fairly, which are essential for preserving democracy.

Our January 17 program features three prominent judges who will speak on these roles and the importance of our judiciary in American democracy. Topics will include:

- An overview of federal and state court systems
- The difference in selection processes for federal and state judges/administrative judicial officers
- Services the Nevada County court provides to our community
- Judicial training and ethics
- How judges manage bias in legal decisions

We will also gain perspective on current legal decisions by looking at past Supreme Court cases. This discussion will provide an overview of stare decisis (the doctrine that precedent must be respected) and a perspective on Constitutional Crisis in American history.

Judge Kelly Babineau (cont.): Judge Babineau was appointed to the Nevada County Superior Court in 2023. She currently presides over Juvenile Dependency, Juvenile Justice, Family Law, and Domestic Violence.

Prior to her appointment, Judge Babineau worked predominantly in the criminal defense field, both as a public defender and private counsel since 1997.

Her work, both as an attorney and a judicial

officer, is fueled by her fundamental belief in public service. She strives to treat all that come before her with kindness, while ensuring all people are provided fair and equitable access to justice.



Her hobbies are hiking, gardening, cooking and hanging out with her husband and 4 cats.

Judge Kent Kellegrew (cont.): Judge Kellegrew was appointed to the bench for the Ventura County Superior Court in 1997 where he presided over civil, criminal, family and probate matters. Over his 24 years on the Bench in Ventura County he served as Presiding Judge of the Appellate Department and Supervising Judge of the East County Courthouse before his election as Presiding Judge for the entire Ventura Court system.

He was appointed to the California Appellate Advisory Committee where his expertise in constitutional law and trial procedure helped guide California's appellate practices. For 15 years, as faculty for California Judge's College, he taught Judicial Ethics and New Judge

Orientation, a required course for newly enrobed judges. He also was awarded Judge of the Year by the Ventura County Trial Lawyers' Association. Before joining the bench, Judge Kellegrew was a Senior Partner at Norman, Cormany, Hair and Compton specializing in complex litigation. Since 2020, Judge Kellegrew sits on special judicial assignment throughout California.



Judge Kellegrew and his wife live in Rough and Ready. His hobbies include making furniture and turning bowls.

Judge Jane Punneo York (cont.): Judge Punneo York is one of the longest sitting trial judges in California. She served as a trial court judge in Fresno County for 22 years followed by 20 years serving as a trial court judge throughout northern California. She has worked in areas of family law, juvenile dependency, and criminal law.

As the presiding judge of the Central Valley Municipal Court, she served on the Executive Committee of the Fresno County Superior Court after trial court consolidation in 1990.

In Fresno County she organized and presided over the first treatment-based drug court. Twenty years later, she still hears from some of her drug court graduates.

Later, she also presided over the first felony level dedicated domestic violence case court calendar. She oversaw 5,000 cases in her 3.5 year assignment. She chaired the Fresno County Domestic Violence Roundtable for 4 years developing protocols among the various agencies involved in the prevention and

treatment of family violence. Judge Punneo York also served on the Judicial Council of California, the administrative policy-making body of the state courts. She chaired Judicial Council Committees and California Judges Association Committees. She also served as a Special Master for the Commission on Judicial Performance on two occasions hearing disciplinary proceedings concerning other judges.



She has lectured in judicial education for the Judicial Council Center for Judicial Education and Research and the California Judges Association, the professional organization of state court judges; and for various agencies and organizations throughout her career.

She and her husband enjoy hiking and kayaking in the mountains. They have shared their home with many rescue dogs. She continues to ride her Morgan horse.

Our System of Education Under Attack

Congress created the Department of Education 46 years ago. But today, the Trump administration is reducing/altering the role of the federal government in education.

The Department's purpose has been to:

- Enforce civil-rights laws in education;
- Administer federal student aid fairly; and
- Promote equal educational opportunities for all students

Over the past year, the Trump administration has worked to dismantle much of the Department's work and role. Some examples:

Civil rights are being ignored, such as not handling discrimination complaints, pressuring schools to dismantle diversity offices and discontinue teaching "divisive concepts."

Staffing cuts keep work from getting done.

Worse, shifting core work of the Dept. of Educ. to other agencies is creating gaps in enforcement. Threatening loss of funding or nonprofit status is being used to force compliance in schools.

Thanks to the Budget Reconciliation or "One Big Beautiful Bill," new barriers to students will shut out millions by slashing financial aid and various loan programs.

Despite the potential revenue to higher education institutions, international students are being denied visas, leaving many students blocked at borders.

AAUW is one of the longest standing organizations committed to improving the lives of women and girls. It is also the largest education funder of graduate work for women. AAUW is very concerned that these moves disproportionately harm women, students of color, low-income, LGBTQ+, and disabled students.

Threats to higher education:

The Trump administration has pressured many universities and colleges to follow Trump's proposed "Compact for Academic Excellence."

Most schools have rejected the

preferential treatment offered, and so may be threatened with a freeze on tuition and government funding, with cancellation of international student enrollment, and having to suppress criticism of conservative ideas and teaching.
